NEW INVESTIGATION: OMBUDSMAN LOOKING INTO LIMITED FUNDING OF HERCEPTIN



The Ombudsman has tasked his Special Ombudsman Response Team (SORT) to investigate the Ministry of Health and Long Term Care's decision not to fund the drug Herceptin for breast cancer patients whose tumours are less than one centimetre in diametre. The team has interviewed affected patients and family members, including Jill Anzarut, whose case was detailed in several media stories, including this one in the Globe and Mail.

The Ombudsman began reviewing the case February 28 and launched the investigation March 18, saying, "Based on our informal interviews with oncologists and officials from Cancer Care Ontario and the Ministry, I've determined that this case raises issues serious enough to warrant a systemic investigation." <u>Read more</u>>>

NEW INVESTIGATION: OPP HANDLING OF STRESS INJURIES

Interviews are underway in the Ombudsman's investigation into how the Ontario Provincial Police (OPP) deals administratively with operational stress injuries (OSI) among its members, after the Ombudsman received some 30 complaints from current and former OPP officers. Launched March 31, the SORT probe is also looking at the Ministry of Community Safety and Correctional Services' administrative processes relating to OSI in police services across Ontario. Among the issues raised by complainants is that those who suffer from depression, anxiety, addiction or post-traumatic stress disorder as a result of their duties are often stigmatized and ostracized and that there is a prevailing attitude that they should just "Suck it up," and get on with their jobs, said Ombudsman André Marin. UPDATE: NON-EMERGENCY MEDICAL TRANSFER PROBE

SORT has completed the evidence-gathering phase of the Ombudsman's non-emergency medical transfer vehicle investigation. The investigation focuses on whether the Ministry of Health and Long-Term Care and the Ministry of Transportation are ensuring that adequate measures are in place in this industry to protect the public in light of complaints about patient safety, lack of infection control and poorly trained staff. The Ombudsman announced in January that the investigation would take 90 days. He is now in the process of drafting a preliminary report and recommendations. Read more >>
