

# Oversight Unseen – Facts and Highlights

## SIU today

**Budget:** About \$5.5 million

**Investigative staff:** 12 full-time investigators; 30 part-time "as needed"; 10 part-time forensic

technicians

**Incidents investigated in 2006:** 226 (Toronto Police and Ontario Provincial Police each account for about one-third of incidents, with the remaining third coming from all other police services)

Charges laid in 2006: 2

Constituting authority: Section 113, Police Services Act.

### **Highlighted cases**

# Jeffrey Reodica, May 21, 2004, Scarborough - page 36

- 17-year-old shot by Toronto officer who thought he had a knife
- SIU notified almost 1 hour after shooting
- First of 10 investigators arrived more than 2 hours after incident; last arrived 6 hours after
- Youth witnesses held at police station until 2 a.m.
- Key witness officer not interviewed until 2 days after incident
- SIU failed to test knife found at scene for DNA

### James Maltar, September 18, 2005, Port Credit – page 36

- Arrested driving car without plates; died from gunshot wound at OPP station
- SIU notified 1 hour later
- First of 8 investigators arrived more than 2 hours after incident; last after almost 5 hours
- Witness officers and civilians not interviewed for more than 1 week

#### Duane Christian, June 20, 2006, Toronto – page 37

- 15-year-old shot by police after charging officer in a stolen van
- SIU not notified for 1 hour and 15 minutes
- First investigator arrived almost 1 hour after notification
- SIU staff called from as far away as Ottawa, canvass of witnesses didn't start for 5 hours
- Mother of deceased was waiting at police station, not notified of son's death for hours
- Key witness officer not interviewed for 6 days; 6 others not interviewed for 17-24 days
- Subject officer was never interviewed, despite being willing

# O'Brien Christopher-Reid, June 13, 2004, Toronto – page 35

- Mentally ill man shot by three officers after lunging with knife
- SIU notified by Toronto police in under 1 hour
- SIU took more than 1 hour to notify staff
- First SIU investigator arrived 2.5 hours after shooting; last called was closest to scene

### Frank Greda, June 27, 2005, London – page 35

- Murdered two children and their mother, killed self after shooting at police
- SIU took 1.5 hours to dispatch 7 investigators
- First investigator arrived 3 hours after incident, last arrived 8 hours after
- Police interviewed surviving 9-year-old girl immediately after she witnessed murder
- SIU didn't interview witness officer until next evening

## Hafeez Mohammed, May 23, 2006, Durham Region – page 43

- Arrested for impaired driving, claimed to be punched and kicked by police
- SIU notified next day but told injury didn't appear to meet "serious injury" threshold
- SIU informed he was in hospital 5 days later with several fractures to face

# Jason Steacy, November 4, 2005, Elgin – page 54

- 20-year-old shot by OPP who thought computer mouse in his hand was a gun
- Three OPP officers on scene designated by SIU within 4 hours; 7 others 2 days later
- Interviews didn't start until 6 days after incident; not completed for 69 days
- Key witness officer on sick leave, lawyer reluctant to give interview
- SIU review found computer mouse was never sent for forensic examination

# **SIU timeline**

1981: Toronto Police set up pilot civilian complaints project – made permanent in 1984

1988: Toronto creates Race Relations and Policing Task Force (in wake of shootings)

1989: Task force recommends independent investigative team for police shootings

1990: SIU created, along with province-wide system for public complaints about police
